Community Grants Program: Application for Funding 2017-18

The Rotary Club of White Plains provides grants to worthy community efforts at the local, regional, national, and international levels. Projects and/or activities funded must promote the mission and ideals of Rotary International and the Rotary Club of White Plains, NY.

The object of Rotary International and the Rotary Club of White Plains, NY, is to “encourage and foster the ideal of service as a basis of worthy enterprise” by supporting the implementation of successful charitable and humanitarian service projects and activities in our local, regional, national or global communities.

This year’s Community Grants Program is focused on serving the White Plains community. Funding requests should be in the range of \$500-\$1,500, and applications are due by December 31, 2017 to the address at the bottom of this form. Notifications will be made on or about January 31, 2018.

Funding guidelines:

1. No Grant shall be given to any organization more than once in any three-year period.
2. The applicant must be a 501(c)(3) organization.
3. A proposed program or project must serve the White Plains community.
4. The purpose of the Grant must be non-denominational.
5. Preference shall be given to smaller organizations having an annual budget of \$500,000.00 or less.
6. An applying organization must describe how the Rotary Club of White Plains will be publicly acknowledged by the organization.
